



Wraparound for Providers AT A GLANCE

What is Wraparound?

Wraparound is a team-based, family-driven, and youth-guided planning process that is driven by a set of guiding principles:

- Family Voice & Choice
- Team-based
- Natural Supports
- Collaboration
- Community-based
- Culturally Competent
- Individualized
- Strengths-based
- Outcome-based
- Persistence

Using these principles, a Wraparound Coordinator will provide a structured planning process that supports a youth and family’s vision and desired outcomes utilizing strengths and needs specific to the youth and family. Wraparound is structured into four distinct phases with facilitated components and activities:

- Phase 1: Engagement
- Phase 2: Initial Plan Development
- Phase 3: Plan Implementation
- Phase 4: Transition

How Does Wraparound Impact My Work as a Provider?

As a community provider, you may be asked by a Wraparound Coordinator to be part of a Wraparound team per the request of the youth and family.

If you are invited to participate in a Wraparound planning process, your time spent in the Wraparound team planning process is reimbursable. The Wraparound Coordinator will communicate with you to discuss your role in the youth and family’s life, identify ways in which you can participate in the Wraparound planning process, and how the Wraparound planning process can support your goals as a community provider.

Where Can I Get More Wraparound Information?

Wraparound is part of the Youth Empowerment Services (YES) system of care in Idaho. Wraparound is intended to assist youth and families who may be experiencing high levels of needs or are at risk of more intensive services, including out of home placement.

To find out more information, you may contact your local regional Children’s Mental Health office to get your questions answered. If you would like to refer a youth and family for Wraparound you may also contact the local Children’s Mental Health office to complete a referral.

Are there admission criteria for a youth and family to access Wraparound?

If you know of a youth and family that may benefit from a referral and entrance into your local Children’s Mental Health regional Wraparound program, you may contact the local regional office to speak

with a Wraparound Coordinator about the youth and family you are referring. Youth with the following characteristics may be appropriate for a Wraparound planning process if:

- they have overall CANS level of three
- are multi-system involved and
- the youth and family desire a Wraparound planning process.



Once a referral is received, the regional Wraparound Coordinator will connect with the referred youth and family and identify their desire to participate. If the youth and family desire to proceed, the Wraparound Coordinator will work with the youth and family and connect with you, the referral source to discuss what Wraparound is and how this planning process is beneficial to you, the youth and the family.
